- 1) **2020 Elevator Industry Field Employee Safety Handbook.** **CEU = .1 hour**
  - a. In webinar settings
  - b. Bring your 2020 safety Handbook to class or, if appropriate, your company's safety policies. We will address one of the nine safety absolutes.
  - c. Please be prepared to review and discuss Car Top Access/Egress, Section 8.1. This presentation is of extreme importance. It deals with a subject where elevator professionals find themselves involved with in their daily life. Over time, some might become lax in their efforts and not understand just how dangerous accessing the cartop can be. Our intent is to review the general access procedures, to reinforce and if necessary, re-educate. Improper cartop access has led to many life changing events over the years. Let's review the process and maybe reduce the accident occurrences.
  
- 2) **NEC NFPA 70– 2023 Code update** **CEU= .2**
  - a. In webinar settings
  - b. Today, we will take you through the article changes in the latest edition of NEC - 2023. The intent is not to cover every change in NEC but to effectively address the changes affecting elevators, escalators, and platform lifts.
  - c. It will be in the students' best interest to have the latest edition in their personal position at the training event, as we will show them the changes with an explanation of why they changed.
  - d. There will be a Quiz at the end to promote attention and learning. You may wish to take notes.
  
- 3) **ASME A17.6-2022 (Revision of ASME A17.6-2017)** **CEU= .15**
  - a. In webinar settings
  - b. This Standard covers the means and members of suspension, compensation, and governor systems for elevators within the scope of ASME A17.1/CSA B44. The Standard includes the material properties, design, testing, inspection, and replacement criteria for these means. Most of the class is addressing the replacement criteria and the addition of part 4 in this 2022 edition.
  - c. Please bring your current edition to class.
  - d. There will be a Quiz at the end to promote attention and learning. You may wish to take notes.
  
- 4) **QEI-1 renewal requirements section 2.3** **CEU = .05**
  - a. In webinar settings
  - b. As several AHJs have commented to NAESA, and it has become apparent that their issues surround the certification renewal process. As part of the renewal process, you are asked a series of questions. If you are certified via NAESA, they are the MOQ questions. Well, let's first dive into where these MOQ questions originate from!
  - c. We will review section 2.3 of **QEI-1** to help create a better understanding of the application of QEI-1.
