#### 1) 2020-8.2 Elevator Industry Field Employee Safety Handbook. CEU = .1 hour

- a. Webinar
- b. Bring your 2020 safety Handbook to class or, if appropriate, your company's safety policies. We will address one of the nine safety absolutes; time will not allow us to review them all this year.
- c. Please be prepared to review and discuss Pit Access/Egress, Section 8.2. This presentation is of extreme importance. This is a topic faced daily by elevator professionals that are accessing dark, dangerous, and potentially fluid filled spaces. Over time, some might become lax in their efforts and not fully understand the repercussions of their actions. Our intent is to review the general access procedures, to reinforce and if necessary, reeducate. Improper pit access has led to many life changing events over the years and the number one common denominator has been human error.
