### **Inspection Methods and Using A17.2**

**1) Inspection methods;** It is expected the attendee have ASME A17.1, ASME A17.2 and QEI-1 available for this class.

The training session will take the attendee through an in-depth review of;

- Types of Inspections, Inspection Resources, QEI-1 expectations, AHJ expectations, How to Evaluate the Equipment, Reports, writing a citation, Legal requirements and what should you inspect then
- Several Practical Application Exercise. These exercises are intended to assist not only in locating the proper references but to address techniques in writing the correction in a manner attributed to the inspectors' QEI-1 2.2 job duties.

The intent of the core is to familiarize the attendees with aspects of inspecting, the detail from preparation to final report writing as expected by the elevators codes and QEI.

Attendees should include Inspectors, Inspectors Supervisors, Mechanics and AHJ including management.

**Codes used:** ASME A17.1-2013. A17.2-2014. QEI-1-2013

**2) Using A17.2** The training course is a interactive and intended to teach the use of and many uses contained within A17.2 Guide for Inspection of Elevators, Escalators and Moving Walks.

It is strongly encouraged that a copy of A17.2 and A17.1 be brought to this class.

The training session will take the attendee through a brief history, Format and Layout. Form and arrangement a review of contents to include the mandatory and non-mandatory appendices, links to and from A17.1 specifically category one and five tests and 8.11 periodic inspections and with time permitting five practice scenarios.

The intent of this core course is to familiarize the attendees with A17.2, its function within our inspection industry and it's many uses in the field.

Interested attendees include Inspectors, Mechanics, Supervisors, Managers and anyone else interested in how the ASME A17.2 is to be used and the many tools contained within available to the elevator industry.
