WEBINAR:

NFPA 13 & 72 and FEO, OEO & FSAE

Date: Saturday, April 7th, 2018

Time: 10:00am-3:30pm (Central Standard Time)

1) NFPA 13 & 72 The training secession is a code update which will include associated current changes contained within A17.1, NFPA 13 and NFPA 72. The class will take the attendee through basic historical codes useful in understanding the progression and performing periodic inspections. Then a detailed review of NFPA 13, with definitions and information about sprinklers, how to determine their rating and when and where they are to be installed including when and where for shunt trip. Followed by a study of NFPA 72, initiation devices, what type, where there to be used, tested and maintained. Throughout the course it will be shown and explained how ASME A17.1 is intertwined with the two NFPA's.

The intent of the course is to familiarize the attendees with the history and current requirements for Sprinklers, shunt trip, Initiation device and periodic inspecting for elevators.

Attendees should include Inspectors, Inspectors Supervisors, Mechanics and AHJ and management.

Codes used: NFPA 13-2013 & 2016, NFPA 72-2013 & 2016, ASME A17.1-2013 & 2016, Several historical references to the NFPA's and A17.1.

2) FEO, OEO & FSAE The training course is a interactive, fast paced review of Firefighters Emergency Operation including a detail review of A17.1 section 2.27.3 with updates of the 2016. Then a detailed review of the 2015-IBC requirements for Fire Service Access Elevators. Finally, we step into Occupant Evacuation requirements both in IBC 2015 and A17.1-2013 & 2016.

The training secession will take the attendee through A17.1 FEO requirements, IBC requirements for FSAE and OEO. Then a detailed review of A17.1 OEO operation and with time permitting six code practice questions at the end.

The intent of this core course is to familiarize the attendees with A17.1 and IBC requirements for FEO, FSAE and OEO operations, their function within our elevator industry.

Interested attendees include Inspectors, Mechanics, Supervisors, Managers and anyone else interested in how the ASME A17.1 and IBC are to be used.

It is strongly encouraged that a copy of A17.1 be brought to this class.

Codes used: ASME A17.1-2013/2016 and IBC 2015
