## **ASME A17.1 – 8.11.4 Periodic Inspection of Escalators**

**CEU= .3**

- a. Webinar (live) settings
- b. We will review **ASME A17.1** as the precursor to the use of A17.2. Section 8.11 sets up the requirements to perform inspections. 8.11 directs us to the A17.2 guide, which standardizes the work performed by the inspector. Eighty-seven years ago, A17.2 was created to assist in the standardization of inspections and tests. We will review the inspection procedures required by 8.11.4 and their corresponding inspection procedures in A17.2.
- c. There will be a Quiz at the end to promote attention and learning. You may wish to take notes.

## **5) NFPA 13 and NFPA 72– 2022**

- a. Webinar (live) settings
- b. Today we will take you through the article changes in the latest edition of **NFPA 13-2022**. - c. Within part 2, we will take you through the article changes in the latest edition of **NFPA 72 -2022**. The intent is not to cover every change in the Alarm code but to effectively address the changes affecting elevators, escalators, and platform lifts. It will be in the students' best interests to have a copy of NFPA 72 at the training event, as we will show them the changes with an explanation of why the changes.
- d. Note that this is a code update class, not a deep dive into understanding the sprinkler or alarm codes.
- e. There will be a Quiz at the end to promote attention and learning. You may wish to take notes.
