You will be notified by email whether you are approved, denied or we need additional information from you.

Book before September 15th, 2023, for a room rate of \$179 per night plus tax and fees.

COST: Registration for the Course and Exam is \$1295. Registration for the Test only is \$500. Cancellations will be refunded if written notice is given to the NAESA Executive Office at least two weeks before the start date of the course, minus a \$50 cancellation fee. No refunds will be given after this date. You will be allowed to attend a substitute course/exam if you contact the Executive Office ahead of time. No refunds on no-shows.

EXAM INFORMATION: The QEI Certification exam is an online, open-book exam consisting of 160 code questions and 6 demographic questions. You will have 8 hours to complete the exam. A half an hour break is required.

IMPORTANT: YOU ARE REQUIRED TO BRING A LAPTOP WITH AN INTERNET CONNECTION. YOU WILL ALSO BE REQUIRED TO DOWNLOAD SOFTWARE ON YOUR COMPUTER BEFORE YOU ARRIVE. MORE INFORMATION REGARDING THIS WILL BE EMAILED TO YOU ONCE YOUR APPLICATION IS APPROVED.
